Client must provide a safe, level setup area with clear access.

If long transport is required from the parked vehicle to the setup location, additional fees may apply. If obstacles, stairs, or restricted access make setup difficult, a setup fee may be applied.

Equipment Responsibility

The client assumes full responsibility for all equipment during the rental period.

- Equipment must be treated with reasonable care.
- The client may not move, rearrange, modify, or disassemble any boards or equipment once set up.
- Any damage, loss, or theft is the responsibility of the client.
- Repair or replacement costs may be charged if equipment is damaged beyond normal use. The

client is responsible for the actions of all guests, invitees, visitors, or trespassers at the event.

Liability

Keystone Mobile Mini Golf is not responsible for any injuries whatsoever that may occur during the use of the mini golf equipment.

Use of equipment is at the participant's own risk. The client is responsible for supervising all participants and ensuring safe use of the equipment.

Weather Policy

Mini golf may be played indoors or outdoors. In the event of severe weather, the event may be moved indoors or rescheduled based on availability. Deposits are non-refundable but may be transferred to a new event date.

Cancellation Policy

- Cancellations made 7 days or more before the event may reschedule without penalty.
- Cancellations made within 7 days of the event may result in forfeiture of the deposit.

Right to Remove Equipment

Keystone Mobile Mini Golf reserves the right to remove the mini golf course and equipment at any time if misuse, unsafe behavior, or violation of this agreement occurs.

Additional Fees

Any additional fees must be mutually agreed upon by both the renter (client) and Keystone Mobile Mini Golf. Additional fees may include extended travel distance, difficult setup locations, long transport distances, or equipment damage.
